PARISH COUNCIL MEETING held on Wednesday 8th March 2023 at the Village Hall, Pinfold Lane, Cheslyn Hay at 7.00 pm

1. **08/03/130 PUBLIC PARTICIPATION**

- 1.1 Residents attended the meeting to raise their concerns regarding planning application 23/00175/FUL, installation of small industrial wind turbine to supplement green energy strategy at BS Eatons Limited, WS6 7EY.
- 1.2 The Clerk disseminated details of the application to Members present.

RESOLVED:-

That the Clerk inform South Staffordshire Council that Members of the public spoke at the Public Participation session to express their concerns regarding the location, distance to closest properties affected, noise affecting other properties in the village (dependent on air dispersal) and the effect on birds.

In light of the objections from local residents, Cheslyn Hay Parish Council propose that an alternative site is sought for the wind turbine at the bottom of the BS Eatons site, adjacent to the Truck Island, where there are no residential properties to be affected.

 - The 'Ironman' competition will be taking place on the 11th June 2023 in Staffordshire;
 - ➤ Staffordshire day is on the 1st May 2023, County Councillor Williams advised all Parish Council's to fly the Staffordshire flag, a discussion was held regarding where they can be purchased.
- 7.2 Councillor Lockley requested an update on timescales for the footpath repairs on the pavements following the diversion route road closures for works on New Horse Road.

Lockley reported that he had attended the public meeting with Chief Inspector Cotton at the Hollybush Garden Centre on the 17th March 2023, only one person attended and security leaflets were distributed. Councillor Lockley was disappointed at the lack of advertising of the event.
- 8.3 District Councillor S. Hollis has spoken to Kelly Harris at South Staffordshire Council regarding issues with the new housing development on Saredon Road, the issues are not planning matters but she has volunteered to speak to Housing Plus and respond to Councillor Hollis.

- 11.2 <u>Election Update and Costings</u> The Clerk reported on the election costs involved should wards be contested at the upcoming elections, charges have been based on administration involved in processing nomination forms and running the election.
- 11.3 Play equipment funding The Clerk reported that Members of the Recreation Ground Committee had met with a playgroup provider on site on the 16th February and two other providers have been invited for quotation.
- 11.4 <u>Meeting with the Chief Executive and Leader of South Staffordshire Council</u> The Chairman and the Clerk met with the Chief Executive and the Leader of South Staffordshire Council to discuss the following outstanding issues:-

 - Planning permission it was agreed that an officer would meet with representatives of the Parish Council to discuss a local issue.
- 11.5 <u>Meeting with Planning Officers</u> The Chairman, Councillors E. A. Davison, J. C. Davison and the Clerk met with Annette Roberts at South Staffordshire Council today to discuss approval of a recent planning application in Cheslyn Hay.

- 11.6 <u>Update on the Parish Summit 10th February 2023</u> The Chairman, Councillors C. and P. Wilkinson and the Clerk attended the Parish Summit which was structured around the health and wellbeing agenda. South Staffordshire Council are offering a pilot 'Cyber Security' project and a meeting will be held shortly inviting Parish Councils.
- 11.7 Meeting with Staffordshire County Council Public Rights of Way Officer The Chairman, the Clerk and the grounds staff met with the Public Rights of Way Officer on the 2nd March 2023 to discuss accessing the footpath at the rear of the Mary Rose Public House and adjacent footpaths 23 and 32 in order to carry out maintenance. A motorbike inhibitor for Low Street was also discussed along with footpath markers, a larger copy of the definitive map and funding for three-tier working.
- 11.8 <u>Turning Circle Rosemary Road</u> Maintenance to the turning circle at the bottom of Rosemary Road was discussed which currently does not have any ownership details at Land Registry.
- 11.9 <u>Finance and Policies Meeting</u> The Clerk has scheduled the next Finance and Policies meeting for 7.00 pm on the 29th March 2023.
- 11.10 <u>Annual Meeting</u> The Clerk reported that the date of the Annual Meeting may have to be changed dependent on seats being contested in the forthcoming elections.
