- 6.1 County Councillor B. Williams reported on the following issues:-
  - ➤ Investigations are taking place as to the ownership of Hatherton Reservoir and Stowe Pool in Cheslyn Hay as the County Council are not responsible for these areas.
  - > Flooding is currently an issue across the County.
  - Members discussed an issue with the lack of road markings at the top of Queen Street, they have been eroded and it is dangerous for vehicles if you are not used to the road layout, other roads within Cheslyn Hay also need attention. Councillor Duncan reported that he has also reported this particular issue.

#### **RESOLVED:**

That County Councillor B. Williams request that the road markings at the top of Queen Street are re-instated due to the road safety implications and that the double yellow lines are extended on Westbourne Avenue.

### 7. <u>10/01/121 DISTRICT COUNCILLORS REPORT</u>

- 7.1 District Councillors R. and S. Duncan reported on the following issues:-
  - ➤ Potholes have been filled recently at Great Wyrley rail station which were allegedly sub-standard, they are keeping a close check on any new repairs carried out.
  - Contact has ben made with the Chief Executive Officer of Severn Trent to discuss the open sewers (pools) on Sutherland Road open space, they are awaiting a response.
  - A request has been made to the Chief Inspector in relation to the content of the local Police reports, they are awaiting a response.
  - > They are liaising with the Director of Homes Plus regarding the disrepair of the local garages in Cheslyn Hay.
  - ➤ They are investigating ownership of Stowe Poole and Walkmill Claypit, Councillor A. W. Emery requested details of the ownership of Hornchwood pool in Cheslyn Hay as there are issues with the lack of 'wheel washes' on this site leaving debris on the road.
